WHEREAS, amendments to Rule 1.490 authorize the Chief Judge of each judicial circuit to appoint general magistrates and refer these cases based on implied consent of the parties to the general magistrates, while providing an opportunity for objection by the parties; it is thereupon

ORDERED AS FOLLOWS:

Pursuant to Florida Supreme Court Administrative Order No. 13-684 and amended Florida Rule of Civil Procedure 1.490, this Court hereby appoints William H. Morrison and Gavin D. Lee, members of the Florida Bar as Foreclosure General Magistrates of the Eighteenth Judicial Circuit Court of Seminole County.

Said Foreclosure General Magistrates shall serve under the direction and of the pleasure of the Chief Judge.

In the capacity of General Magistrates, William H. Morrison and Gavin D. Lee shall:

Take the Oath of Office, attached hereto as required of officers by the Constitution of the State of Florida. The Oath, along with this Administrative Order, shall be properly recorded in the official records of the Clerk of the Circuit Court for Seminole County;

- Perform the duties required in accordance with the above cited rules and statutes and any other rule or statutory provision authorizing the appointment of a General Magistrate, and in accordance with the Code of Judicial Conduct;
- 3. Be a member in good standing of the Florida Bar;
- 4. Serve without the requirement of bond.
