Please do not call the court or the judicial assistant concerning the docket. Attorneys and unrepresented parties have the responsibility to keep one another and the court advised of the trial status of their cases. Plaintiff's attorney is responsible to notify the Civil Trial Coordinator immediately if a case settles. All cases shall be ready to proceed with the disposition of the preceding case.

The Civil Trial Coordinator will attempt to notify attorneys and parties not represented by an attorney of the progress of the trial docket beginning approximately two days prior to the first day of trial. The Trial Coordinator has specific instructions concerning scheduling. She is not a judge and has no authority to grant continuances. Please do not ask her to exceed her authority.
