**TRIAL DOCKET MANAGEMENT:** The trial docket is managed by the Case Manager. The Case Manager will answer any questions concerning the progress of the docket. Attorneys and unrepresented parties have the responsibility to keep Court advised of the trial status of their cases.

**NOTIFICATION OF SETTLEMENT:** The parties shall be responsible for notifying the Judicial Assistant and the Case Manager, [DivisionWCM@flcourts18.org](mailto:DivisionWCM@flcourts18.org) of settlement by immediately emailing a statement regarding settlement arrangements and requesting that the matter be removed from the trial docket.

**TRIAL EXHIBITS:** If the parties are appearing via TEAMS, they must prepare an Exhibit List, with pre-marked agreed to exhibits. Exhibits must be clearly marked as A, B, C, D, etc. Two hard copies of all trial exhibits and documents for the Court's consideration must be delivered to the Judge's chambers no less than 72 hours in advance of the trial and will not be accepted or admissible after that.
