PLEASE DO NOT CALL THE COURT OR THE JUDICIAL ASSISTANT CONCERNING THE DOCKET. Attorneys and unrepresented parties have the responsibility to keep one another and the court advised of the trial status of their cases. The attorney for the petitioner shall be responsible for notifying the Family Coordinator immediately if a case settles.

The Family Coordinator has specific instructions concerning scheduling. The Family Coordinator is not a judge and has no authority to grant continuances. Please do not ask her to exceed her authority.
