This Handbook has been designed to provide you with information and answer any questions regarding the Brevard County Juvenile Drug Treatment Court (JDTC) Program. As a participant, you and your parent(s) or guardian(s) will be expected to comply with all conditions of supervision that the Court has ordered. This includes following the recommendations of various agencies regarding a treatment plan that will be developed for you and your family.

As a participant in the JDTC, you have been offered an opportunity to move in a new direction in your life to help you avoid more serious consequences because of your continued drug and/or alcohol use. This handbook will detail what is expected of you and your family as a JDTC program participant and review the general guidelines for the program. Our goal is to provide close supervision and quality treatment services to assist you in developing and maintaining a drug-free lifestyle.



The mission of the Brevard County Juvenile Drug Treatment Court (JDTC) is to provide effective intervention, treatment, and guidance to youths placed into the criminal justice system by activity related to drugs and/or alcohol, thereby making the community safer and setting the youths on a path to success to lead healthy, productive lives, and to become assets to the communities they live in.



We want to stop the use and abuse of alcohol and other drugs in your life. We are committed to helping you overcome your use of alcohol and other drugs. We want to help you learn how to lead a drug free lifestyle and help you build better relationships with your family and the community you live in. We are committed to your future and to your development into a happy, healthy, and productive person.

Your Juvenile Probation Officer (JPO) or Diversion Case Manager (CM) will review this booklet with you and your family during the orientation period, however it is your responsibility to read and understand what is expected of you, how the program works and the rules of the program. Your JPO or CM will also be available to answer any questions you may have.

### **ELIGIBILITY REQUIREMENTS**

Youth ages 17 and under, on probation or pre-trial diversion **OR** violating either program due to drug/alcohol use or associated behaviors, drug related crime or crimes committed due to drug use (no violent felony charges), self or family disclosure of substance abuse history or current use/abuse.

### **PROGRAM DESCRIPTION**

You have been selected for this program mainly because you have continued to use drugs or alcohol. Drugs and/or alcohol appear to be a significant problem in your life, and intensive supervision is necessary for your rehabilitation and for public safety.

The JDTC program is divided into four (4) phases. Each phase deals with your drug and alcohol issues and includes services to help you with other things going on in your life. Your family will also be getting involved with your treatment.

Each phase is made up in such a way that as you do better, learn and understand more the phases get easier. Phase 1 is an orientation phase where you will get acclimated where you will learn what is expected of you and how things are done. During this time, you will have an intake appointment for both supervision and treatment. During these intake appointments you will work with your JPO, CM and/or treatment counselor to create your case and treatment plans, assessments will be completed, evaluate your school status and needs, programs rules, drug testing procedures and rules etc. During Phase 2 you will start treatment, working on court ordered sanctions/conditions, identifying specific needs or services that will help you succeed and remaining drug free. By the time you reach Phase 3, you will be a pro on what is expected of you and how the program works. The treatment and education services you receive will help you learn how to understand yourself, as well as, and what you need to do to improve your life and maintain sobriety. Each phase and the associated goals are listed below.

## Drug Court Program Phases

### Phase 1: Assessment and Orientation (approximately 30-45 days)

1. Assessing youth & families through structured intake procedures.
2. Developing comprehensive case plans and goals.
3. Building relationships and orienting youth & families through supervision meetings and court appearances
4. School assessment.
5. Schedule/complete treatment intake appointment.
6. Drug testing rules and procedures.
7. Weekly court attendance; Court process, attendance, and expectations
8. Incentive and point system overview.
9. Curfew and drug court rule compliance.
10. Receive recommendation from treatment to be promoted to Phase 2.
11. Prepare and present your checklist to the judge and drug court team for promotion.

### Phase 2: Intensive Treatment and Education

1. Bi-weekly court attendance and goal reporting.
2. Random drug testing 2-3 times per week.
3. Start and attend treatment sessions.
4. Start working toward sobriety maintenance.
5. Case plan review/progress.
6. Follow school assessment and plan.
7. Curfew and drug court rule compliance.
8. School attendance and compliance.
9. Receive recommendation from treatment to be promoted to Phase 3.
10. Prepare and present your checklist to the judge and drug court team for promotion.

### **Phase 3: Rehabilitation and Relapse Prevention**

1. Court attendance as needed.
2. Random drug testing 1 time per week.
3. Treatment attendance and progress.
4. Continued sobriety maintenance. Sixty days sobriety needed for graduation.
5. Case plan review/progress.
6. School attendance and compliance.
7. Curfew and drug court rule compliance.
8. Finish completing probation or diversion requirement and sanctions.
9. Receive recommendation from treatment to be promoted for Graduation.
10. Prepare and present your checklist to the judge and drug court team for promotion.

### **Phase 4: Maintenance and After Care Planning**

1. No missed or positive drug tests.
2. Sixty or more days sobriety.
3. School attendance and compliance.
4. Treatment completion and final review.
5. Case plan completion and final review.
6. ALL probation or diversion and drug court conditions/requirements MUST be completed.
7. Develop a personal aftercare plan including behavioral changes, positive peers, family engagement etc.
8. Receive a completion and graduation recommendation from treatment, as well as your JPO or CM.
9. Prepare and present your graduation checklist to the judge and drug court team.
10. Present your personal journey through drug court essay and advice you have to the other participants.

Once you have successfully completed this portion of treatment, have all court ordered sanctions/conditions completed and court costs and/or restitution paid, you will be eligible for graduation from JDTC.

Graduation from the JDTC Program is recognized as a very important event. Family members will be invited to a special ceremony recognizing participants for successfully completing the program and achieving personal goals.

## INCENTIVES AND SANCTIONS

Throughout the duration of the JDTC program, incentives and sanctions are provided as a source of motivation for the participants. Incentives and sanctions are determined on an individual basis; factors include the participant’s development level, interests, and causes for compliance or noncompliance.

### **Incentives:**

Throughout the program you will have the opportunity to earn incentives/rewards in the form of a “point system”. Points will be awarded to you for everything that you accomplish in all phases of the program. The chart below outlines all of the things which may earn you points including having a positive attitude. The more points that you earn, the more prizes/rewards you will be able to buy with your points. Additionally, bonus points can be earned for additional, exceptional behavior as indicated below. Points can only be earned while in compliance/good standing. Points will NOT be lost while in a non-compliance stage, however, they will “freeze” and you will not be able to use them until you are back in compliance or good standing.

Participants can also win extra “Mystery Box” drawings for negative drug test in court, “caught being good” or doing something above and beyond, from the judge as kudos for accomplishments, progress, outstanding behavior, attitude, or other special circumstances.

**Sanctions:**

Violations of the JDTC rules may result in sanctions. A listing of violations and possible sanctions have been provided in the chart below. The chart is not inclusive of all violations and/or sanctions and the Judge maintains discretion.

## DRUG COURT HEARINGS

Attendance at court hearings will depend on what phase you are in. Every participant is required to appear in Court for their acceptance into JDTC, as well as, through Phase 1 (orientation phase). During the orientation phase participants will be required to attend court weekly. In Phase 2 you will be required to attend court bi-weekly or as advised by your JPO or CM. Thereafter, if you are doing well and have no positive drug tests or other violations you will only come for incentives, rewards, meetings or graduation. If you are experiencing problems or having issues your JPO or CM can set you on the docket to discuss those problems or issues.

**Remember: Appearance at Juvenile Drug Court hearings are mandatory. If you fail to appear, a Take into Custody Order (TICO) will be issued for your arrest.**

## PROBATION / DIVERSION REPORTING

You are required to report to your juvenile probation officer (JPO) or diversion case manager (CM) as directed and outlined in your intake.

### CONFIDENTIALITY

Your Juvenile Drug Treatment Court records are protected under federal regulations and cannot be disclosed to anyone else without your consent. This means we cannot talk about you to anyone else who is not involved in the program, unless you AND your parent or legal guardian say it is okay.

The team and participants will also have to sign a form promising that they will not disclose information about you to anyone else without you and your parent/guardian's permission, except as may be permitted by law. Everyone will agree to be bound by confidentiality laws and requirements. If they do not agree, they will not be allowed to participate.

In addition, your consent is revocable. This means you can take back your consent at any time. However, this would mean you could no longer be in the Juvenile Drug Court Treatment Program and would be referred back to the regular juvenile delinquency docket.

If you have any questions about confidentiality, ask your attorney, the probation officer (JPO), the case manager (CM), or the Judge.

**Remember:** JDTC hearings are open court hearings, just like being in delinquency court for any other reason. This means that as you speak to the Judge, everything you say will be heard among other participants as well as anyone else who may be in the courtroom. You should feel comfortable in speaking freely with the Judge, but if you have any concerns or want to speak more privately, let the Assistant Public Defender, probation officer (JPO), case manager (CM), or Judge know.

### MEET THE JDTC TEAM MEMBERS

The Brevard County Juvenile Drug Treatment Court takes a team approach for each of you who enter the program. The team will ensure that you are receiving the best, structured, services possible to ensure your success in the program.

## TREATMENT

The treatment provider for JDTC is Lifetime Counseling Centers (LCC). It is your responsibility to make sure that you contact them within 14 days to set up your intake appointment. LCC has offices in both Cocoa (main) and Melbourne. **Please call LCC at (321) 632-5792 to get your appointment scheduled.**

**Intake and Assessment:** After acceptance into the program, you will be required to complete an intake and assessment with Lifetime Counseling Centers. Intake appointments must be made within 14 days of acceptance and completed within 30 days of acceptance.

**Treatment Plan:** Based on your assessments and personal needs an individualized treatment plan will be created by you and your counselor.

**Group Counseling:** You will be required to attend weekly group counseling with a counselor and at least one other participant, but no more than 12 participants meeting as a group. You are required to participate and complete any assigned work.

**Individual Therapy:** One-on-one counseling with a therapist; no one else, just you and the counselor.

**Family Therapy:** This is special counseling for you and your family member(s) with your counselor. Your family support is important to your success.

## PARENT/GUARDIAN PARTICIPATION

The JDTC will actively engage the family throughout the duration of the program. The JDTC acknowledges that family engagement is an essential key to the participant's success in the program. The JDTC uses a strength-based family centered approach in making decisions, setting goals, establishing case/treatment plans to achieve desired outcomes for youth and families.

The JDTC shall encourage collaboration and family engagement to ensure that participant is fully surrounded by support. Parents are required to:

1. Participate in monthly family and parent treatment groups.
2. Accompany participant to court appearances.
3. Provide or secure transportation to both treatment and court appearances.
4. Provide input on participant's progress or regression.
5. Report violations of drug court rules to probation officer or diversion case manager.

The JDTC will ensure that they provide court-certified interpreters for parents and/or guardians with limited English proficiency during court status hearings. Those with hearing deficiency shall be provided with a sign language interpreter as needed.

## PROGRAM RULES

**Appropriate Dress:** Juvenile Drug Court participants are expected to dress appropriately for all activities. Clothing displaying drugs/alcohol/tobacco, gang symbols, colors, or offensive or obscene pictures or language is prohibited. Hats or sunglasses are not to be worn in court or at the treatment sessions. School dress code is in effect for all meetings and court hearings.

**Language and Behavior:** During all Juvenile Drug Treatment Court (JDTC) activities, participants and family member(s) are to refrain from the use of profanity or other disrespectful behavior. No racist, sexual, violent, or other offensive comments will be tolerated. Abusive behavior in the form of insulting language, physical gestures, aggression or other behavior will not be tolerated and will be sanctioned.

**Courtroom Behavior:** The JDTC expects all drug court participants to show respect and courtesy to all courtroom staff, families in attendance, and other observers. It is expected that participants and their families will abide by Court rules. You are expected to set a good example for others.

**Weapons:** No weapons are allowed at any Juvenile Drug Court activity. If a weapon is found on a participant, he or she may be subject to termination from Juvenile Drug Court and/or may be otherwise sanctioned.

**Smoking/Electronic Smoking Devices:** Smoking is prohibited at **all** times for all juvenile drug court participants.

**Punctuality and Advance Notification of Absences:** Drug Court participants are expected to be on time for all Drug Court activities. A record of attendance and/or tardiness will be reported to the Court and subject to sanctions.

**School Attendance:** You must attend school daily (when in session) without any unexcused absences or tardies.

**Treatment/Counseling:** You must attend and participate in your weekly group sessions, as well as, any individual or family sessions as indicated in your treatment plan.

**Consumption of Drugs/Alcohol:** You may not consume any alcohol or illegal drugs; prescriptions not written for you; or any other substance in a mood-altering manner while participating in JDTC. You are also expected to take any prescription medications as directed by your prescribing physician. Copies of all prescriptions that you have been prescribed must be given to your JPO or CM.

**Drug Screening:** You will be required to submit urine samples (UA) on a random basis. Some participants may have to give more than one per week. You are subject to random tests as requested by the judge, treatment provider, probation officer or diversion case manager. All POSITIVE urine samples are sent out for laboratory confirmation using Gas Chromatography Mass Spectrometry (GC-MS). GC-MS also helps eliminate the possibility of a false positive from other substances or liquids that may have been ingested (i.e. poppy seeds, energy drinks, OTC medications, etc.).

**Tampering with a drug screen** – tampering means:

- If you try to put anything else in the collection cup other than your own urine, even your own finger.
- If you try to block or hide from the observer's view.
- If you do not follow the observer's directions.
- If you have anything else in your hands, taped or concealed in, or on your body such as a balloon, a tube, a bottle, a hose, an apparatus specifically used to defraud, **or anything else other than the collection cup.**
- Scooping toilet water or water from sink. This invalidates the temperature on the cup and therefore considered a positive result because you are tampering with the test to hide potential usage.
- Deliberately drinking excessive water or other liquids to invalidate the test.

**Dilute Urine Samples:** A dilute urine sample will constitute as a positive test result, and you will be placed on home detention until a proper urine sample can be tested. If your urine is reported from the lab as “dilute” which means the sample does not contain enough concentrated urine to test the sample.

**Tampering/Dilution may result in immediate sanction and/or discharge from the Juvenile Drug Court program.**

**1<sup>st</sup> Dilute Urine:** A warning will be given, and you will be placed on home detention until a proper sample can be taken.

**2<sup>nd</sup> Dilute Urine:** Secure detention.

**3<sup>rd</sup> Dilute Urine:** Secure detention and possible removal from the program.

*\*If you have a medical condition that causes your urine to be diluted you are required to produce medical documentation from your doctor and provide it to your treatment counselor, JPO, CM or the Court.*

**Refusal or avoidance to test:** if you refuse to take a drug test or purposely avoid/evade drug testing it will be considered a **POSITIVE** test result. Additionally, you will be placed on home detention until you test. Continued refusal or avoidance will cause you to be terminated from the program.



## **TAKING MEDICATIONS**

---

You may **NOT** consume any alcohol or illegal drugs; prescriptions not written for you; or any other substance in a mood-altering manner while participating in JDTC. You are also expected to take any prescription medications as directed by your prescribing physician.

**Over the Counter (OTC):** You will need to notify your JPO or CM **before** taking any kind of OTC medications, especially the following:

- Cold and Flu medications, such as Sudafed, Cordicidin and/or D, Contact, Tylenol Cold Plus etc.
- Allergy Medications like Claritin, Zyrtec, Allegra.
- Cough Medicines, Like Robitussin, Vicks 44 etc.
- Liquid cold/flu drinks- Absolutely No Nyquil, or anything containing alcohol.
- **NO** CBD oils or products.
  - **NO** natural or synthetic herbs or substances or liquids such as K2/Spice, Delta 8/9, Kratom, methoxetamine (MXE), bath salts, or other known substances that cause you to be impaired.
- **NO** Flushing or cleansing agents.
- **NO** Vapor pens, Juul, or any other electronic smoking devices or any vaping liquids, substances or materials.

**Prescribed medication from you doctor:** You should advise your doctor immediately that you are in a drug treatment program and that you are tested for drugs on a regular basis. You must show proof of all prescriptions from the doctor to your JPO or CM.

## HOME DETENTION RULES AND REGULATIONS

1. I will remain at my place of residence and will not leave or change my approved residence without the prior consent of my JPO or CM.
2. I will remain in my home at all times of day or night except:
  - A) While attending school/employment during scheduled hours, approved by my JPO or CM.
  - B) When JPO or CM has granted prior approval.
  - C) If there is an emergency where I must immediately inform my JPO or CM.
3. I will attend school and all my classes regularly, unless my parent, guardian, JPO or CM gives me permission to remain home. It is my responsibility to call my JPO or CM if I must stay home from school.
4. I will obey all school rules and regulations set by school officials and will go directly to school and home unless my JPO or CM grants permission. If I am suspended from school, I understand I may be returned to secure detention.
5. I will report to work as scheduled and will go home directly after work. I will notify my JPO or CM if there is a change in my work schedule and provide written proof of the change.
6. I will not drive a car or other motorized vehicle, unless I have a valid Florida Driver's License and prior consent of my JPO or CM.
7. I understand that I will attend all court hearings and scheduled appointments, failure to appear may result in being held in contempt of court.
8. I will not use or possess any controlled substance / alcoholic beverage, stolen property nor will I commit any new law violations.
9. I will not possess, carry, or own any weapons or firearms.
10. I will not associate with any identified co-defendants, victims and anyone deemed inappropriate by the court, JPO or CM, and/or parent/guardian etc.
11. I will not violate any law and doing so will result in a violation of this contract. I further agree to report any law violations or violations of this agreement to my JPO or CM within 24 hours.
12. I understand there will be unannounced visits during the period of my supervision.
13. If I am placed on the electronic monitoring program, I will comply with all the rules and regulations, required by that program, as instructed by my JPO or CM.
14. I will not leave the county of my residence or leave the state without the consent of my JPO or CM.
15. I understand that failure to abide by any of the rules listed in this contract may result in my return to **secure** detention.

**\*This contract will be in effect until notification from your JPO, JDAP case manager and/or the Court.**
