


ORDER COMPENSATING EXAMINING COMMITTEE MEMBERS

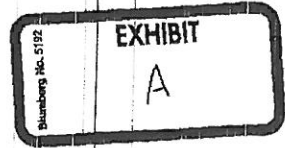
