

## BUMMARY INFORMATION:

ON 07-18-05, IN ORANGE COUNTY, FLAT COMMITTHE OFFENSE OF OBSTRUCTION OF JUSTICE, RESISTING AN OFFICER WITH VIOLENCE AND SATTERY ON A LAW ENFORCEMENT

WHILE WORKING AN INVESTIGATION IN PLAIN CLOTHES AT THE ABOVE LOCATION, I WAS ASSISTING OTHER AST AGENTS CUTSIDE OF THE ABOVE MENTIONED CLUS. WE HAD PLACED SEVERAL BAR EMPLOYEES UNDER ARREST AND SAT THEM DOWN TO THE SIDE OF THE CLUS AWAY FROM THE PRONT DOOR AND WIENE WAITING FOR OCSO TO ARRIVE TO TRANSPORT THE ARRESTEES TO THE COUNTY JAB., WHILE WE WERE GATHERING INFORMATION FOR ARREST REPORTS A WAN LATER IDENTIFIED AS SIZIMBERMAN WALKED UP TO A FREND OF HIS WHOM WAS UNDER ARREST AND BEGAN TALKING TO HIM THUS INTERFERING WITH OUR EFFORTS TO INTERVIEW THE SUBJECT.

I IDENTIFIED MYSELF AS A STATE POLICE OFFICER AND SHOMED SIZMMERMAN MY BADGE AND ASKED HIM TO LEAVE THE AREA. HE STATED, "DON'T CARE WHO YOU ARE", I AGAIN ASKED SIZMMERMAN TO LEAVE, HE THEN STATED, "FUCK YOU". AT THAT TIME I ATTEMPTED TO ESCORT BIZMMERMAN AWAY FROM THE INTERVIEW AREA, HE SHRUGGED AWAY FROM ME AND THEM, PUBHED MY ARMS AWAY WITH HIS HANDS. AFTER A SHORT STRUGGLE WITH SIZMMERMAN HE WAS PLACED IN HANDCUITTS AND DETVINED UNTIL, OCSO, ARRIVED.

SZEMMERMAM WAS TRANSPORTED TO THE COUNTY JAIL BY OCSO. SZEMMERMAN WAS CHARGED WITH OBSTRUCTION OF JUSTICE, RESISTING AN OFFICER WITH VIOLENCE IN VIOLATION OF FES 843.01 AND BATTERY ON A LAW ENFORCEMENT OFFICER IN VIOLATION OF FSS 784.07.
