**IN RE: MAGISTRATE – TEMPORARY APPOINTMENT OF GENERAL MAGISTRATE AND
SUPPORT ENFORCEMENT HEARING OFFICER SUZANNE MCQUAGGE**

WHEREAS, in order to expedite the administration of justice in the Eighteenth Judicial Circuit the Chief Judge is authorized to appoint General Magistrates and Support Enforcement Hearing Officers as set forth pursuant to the administrative order currently in effect pertaining to the appointment of General Magistrates and/or Hearing Officers;

WHEREAS, General Magistrates hear matters referred pursuant to Florida Rule of Civil Procedure 1.490 and 1.491, Florida Rule Probate Rules 5.095 and 5.697, Florida Rules of Juvenile Procedure 8.257 and 8.625, Truancy pursuant to Florida Statutes Chapter 984, Florida Family Law Rule 12.490, Florida Statutes Chapters 393, 394 (Baker Act), and 397 (Marchman Act), name changes, annulments and any other matter upon which a rule or statutory provision authorizes the appointment of a General Magistrate.

WHEREAS, Support Enforcement Hearing Officers hear proceedings for the establishment, enforcement, or modification of child support, when the party seeking support is receiving services pursuant to Title IV-D of the Social Security Act, as well as proceedings not brought under Title IV-D, including uncontested paternity matters.

NOW, THEREFORE, by authority vested in me as Chief Judge and pursuant to the Florida Rules of Judicial Administration, I hereby appoint Suzanne McQuagge to serve as a General Magistrate and as a Support Enforcement Hearing Officer for the Circuit Court of the Eighteenth Judicial Circuit of Florida, to perform duties in accordance with the applicable Florida Statutes, federal law, court rules, and the terms and conditions of the Title IV-D program. This Order shall take effect July 1, 2022 and shall continue until June 30, 2023.
