IN RE:       **CRIMINAL - COMMUNITY SUPERVISION AND EXPANSION OF  
PRETRIAL RELEASE PROGRAM**

**Whereas,** it has been brought to the Courts attention that the Brevard County Board of County Commissioners approved an expansion of the Pretrial Release Program to include Community Supervision and the collection of a Cost of Supervision fee pursuant to F.S. §907.041(1)(3) and F.S. §948.09(1)(3)(6), and

**Whereas,** the purpose of the expansion of Pretrial Release to Community Supervision is to provide direct monitoring and guidance of pretrial defendants who do not bond out and do not meet the criteria for PTR, ROR or Signature Bond, allowing their release from jail as well as securing public safety, and

**Whereas,** it is necessary to define the role and scope of such program

It is THEREFORE ORDERED that:

1. The County Supervision Program will conduct an intake interview of defendants at the Brevard County Jail as the director of the program deems appropriate.
2. Recommendations for Admission to the County Supervision Program shall be made to the Court by County Supervision Program officers with suggested conditions of release and level of supervision.
3. Should the Court admit the defendant to the County Supervision Program it will set conditions of release which shall not be modified except by Court order.
4. County Supervision Program officers shall report violations of the conditions of release to the Court immediately and they will be considered violations of conditions of bond.
5. The Community Supervision Program will make referrals to appropriate educational and treatment programs.

Emphasis will be made on job placement, vocational training or educational enrollment.

6. The Community Supervision Officer supervising the defendant shall be present at any scheduled hearing regarding the defendant.
7. Community Supervision will be responsible to provide, as part of the Presentence Investigation, an assessment of the defendant's ability to be supervised within the community.
